Report to the Membership

Dear Customers of Cordova Electric Cooperative (CEC):

This year marks the 47th anniversary of CEC. This year we realized the benefits of improvements to our grid over the last three years. Valve upgrades at the Power Creek Hydroelectric Project and the addition of higher efficiency, lower air emissions diesel generators helped us set a new renewable energy record of over 80% hydropower for the year. Our diesel fuel use reached a record low of 352,000 gallons, down sharply from the 600,000 gallons we used in 2022. The reduced diesel fuel use lowered electric bills 14%, offsetting almost the entire 15.5% rate increase we had to implement in April. We also experienced record system reliability in 2024, with an average of only 23 minutes of average outage time per customer, or 99.996% on time. Our underground power lines assure high reliability of our power distribution system, and now the power generation system is so reliable that we have few outages – over a full year without a single loss due to power generation. These improvements are the primary focus of your Board of Directors and staff: high reliability, reasonable cost, and environmentally responsible energy delivery for Cordova.



CEC was successful in the award of federal grants and low interest loans to develop

hydropower storage to further reduce our diesel use. We have adequate federal financing to add dam storage at our Humpback Creek hydroelectric project, and to develop Crater Lake Dam Storage project. We continue to seek state, federal, and partner grant funding to develop these sites to move Cordova toward 100% renewable generation. Some of this federal funding is to lend to you, our customers, for installation of heat pumps. CEC will be developing a loan fund program for heat pumps as the loan funds are released. The new winter incentive rates resulted in immediately lower bills for some customers and will provide additional savings for new winter energy use for heat pumps, winter seafood processing, winter LED food production, hot tubs, and other uses. These strategies move us in the direction that you as customers have asked us to in our customer surveys; hydropower as the most preferred energy source for the community, and programs to help reduce energy costs like heat pumps and management of electrical rates.


Our outlook for 2025 is optimistic, as we pursue additional funding for hydro projects and engage Cordova in a community benefits planning process to get your input on these projects, to identify all the potential benefits (recreation, education, community water supply, access to affordable winter energy) so that they are not overlooked in the design process. We are adding another highefficiency diesel to replace a failed 40-year-old diesel, and work to grow energy sales so that we can spread our operating costs over more sales to keep our rates down.

We look forward to seeing you at the annual meeting on March 17th at the Cordova Center, and our annual customer appreciation event later this year.



CEC broke a new record in 2024 by producing 80% of Cordova's power with hydro. This accomplishment is the culmination of many different efforts to maximize our hydro resources. In contrast, the rest of Alaska is only about 20% renewable.




Even though we generated 80% of our power with hydro, it was only 17% of the overall expense of generation. While costs can vary from year to year, hydro has consistently proven to be a significantly cheaper source of power compared to diesel.



CEC once again retired capital credits in 2024. Current members automatically had the credit applied to their January electric bills.

Capital credits are the hallmark of cooperative membership and retirement of the credits demonstrate our strong financial performance. Profits, or margins, are allocated to each member on a yearly basis, and get returned back to members at a later date. CEC is proud to return capital credits to our fellow members of the cooperative.




Average Residential Monthly Bill

When adjusted to inflation, CEC's average monthly residential bills have actually trended down over time, meaning the average electric bill in 2012 felt higher than it does today.


Power Generation

Annual kWh sales continue to display a slight downward trend over time. Less sales means that CEC has to recover more revenue per kWh. For an electric utility our size, kWh sales can dramatically change depending on seafood processing, other economic activity, or the gain or loss of one large customer.

Steve Ranney (Incumbent)

Occupation(s): Manager, Orca Adventure Lodge

Community Involvement: I have been on the CEC Board for 2 terms as Secretary, past board member of the Cordova Chamber of Commerce, assistant leader w/ the Boy Scouts for close to 20 years, volunteer to teams, music, NOSB and others

Why are you interested in serving on the CEC Board? I believe I offer a balance to the Board. For me, budgets, projects and decisions must pass a litmus test. How will it affect rates? How does the decision affect the long-term health of the Cooperative?

While adding debt is a useful tool, I feel we need to also be careful not to overburden our future members with an excessively heavy debt load.

My priority at the board level is encouraging increasing sales. To me this is most critical to the cooperative's future, as sales have been in a decline and expenses, of course are on a upward trend.

I encourage members to take a good look at the Heat Pump incentive program CEC has recently implemented. I am happy to talk to anyone interested in heat pumps as well, and my own experiences with them.

Andrew Smallwood (Incumbent)

Occupation(s): Pilot (ret.) / Comm. Fish (Seiner)

Community Involvement: I served on the CEC board in the early 80's and at the same time on the Planning and Zoning Commission. I served for 3 years on the board of the Copper River Fisherman's Co-op. I served for 9 years on the board of Prince William Sound Science Center and am currently again on the board of Cordova Electric Co-op.

Why are you interested in serving on the CEC Board? When the gales of winter lay the trees flat, know that, anywhere else in the nation, the people would be plunged in darkness. Here the lights seldom even flicker. That's because previous boards elected to put our distribution system underground. That was expensive. It took courage.

The current board's challenge is to transition from diesel to hydro power. We are almost 80% of the way there. This is expensive and difficult but essential if we are to control costs in the future. The present Board and Management continually walks a tightrope between over borrowing on the one hand and under investing in the future on the other. I believe we have performed this balancing act with skill and grace so far. I very much want to continue as part of this great team.

I have been involved with CEC, at the board level, since its founding forty some years ago. In all that time we have had to struggle with wildly fluctuating diesel prices over which we have had no control. Our gift to the next generation of Cordovans should be to relieve them of that burden. I would be happy to continue to try and make that happen.


Jeremy Botz


7. NEW BUSINESS - none.
